**MUNICIPAL - Nominating Petitions for PERS Board of Trustees**

**INSTRUCTIONS:**

1. The candidate must be an active or retired member of the PERS and must have at least five hundred (500) eligible MUNICIPAL-PERS member's signatures.

To be eligible to vote, you must be an *active* member of the PERS and an employee of a Municipality in New Jersey.

TO BE A VALID SIGNATURE, THE ACTIVE MEMBER MUST PROVIDE A MEMBERSHIP NUMBER OR SOCIAL SECURITY NUMBER ON THIS FORM. If not provided, the nominating signature will NOT be valid. NJAC 17:2-1.4(d)

**A MEMBER IS PERMITTED TO SIGN ONLY ONE CANDIDATE'S PETITION FORM OR ONE ONLINE NOMINATION.** [HTTPS://VOTE.ELECTION-AMERICA.COM/PERS-MUNICIPAL](https://vote.election-america.com/pers-municipal)

2. Petitions must be received in the board office of the Public Employees' Retirement System, P.O. Box 295, Trenton, NJ 08625, no later than 4:00 p.m. Friday, January 8, 2016. In the event of an election, ballots will be distributed through employers in early April 2016.

3. The elected trustee will assume office at the Board's July 2016, meeting, for a 3-year term ending June 30, 2019.

4. The nominee's name must be shown at the top of each nominating petition, and THE NOMINEE MUST SIGN the bottom of each petition indicating his/her willingness to be a candidate.
